SUPPLY OF COTTON PEST CONTROL INSECTICIDES

- 1. Tanzania Cotton Board has set aside funds for its operations during the financial year 2018/19. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Supply of Cotton Pest Control Insecticides**.
- 2. The Tanzania Cotton Board now invites **eligible tenderers** to submit sealed tenders for the Supply of Cotton Pest Control Insecticides in the following lots.

Tenderers are allowed to tender not more than three lots and in each case tender must quote for any or all items and quantities specified in the lot.

- 3. Tendering will be conducted through the International Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.

A complete set of Tender Documents in English may be purchased by interested Tenderers on the submission of a written application bearing name of the firm, e-mail and postal address, fax and telephone to the address given below and upon payment of a non-refundable fee of TZS. 200,000/- (Tanzania shillings Two Hundred Thousand Only). Payments should either be by cash, banker's cheque, or banker's draft payable to the Director General.
- 6. All tenders must be accompanied by a Tender Guarantee in the format provided in the Tendering Documents.
- 7. All tenders in one original and TWO copies, properly filled in, and enclosed in plain envelopes must be delivered to the address indicated on paragraph 4 above at or before 1400hours local time, Tuesday 21st August 2018. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the TCB Board Room located in the 1st Floor at the Headquarters of the Tanzania Cotton Board, Regional Drive, Mwanza.
- 8. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
